The City expects delivery of concrete to the job site or sites within 24 hours of placing an order.

All job sites will be located no further than two miles outside of the City limits. We expect to use approximately 300-400 yards of concrete per year (85%-3,000psi 10%-4,000, 5%-other) to be delivered between the hours of 7AM and 2PM, Monday through Friday. In the event of an emergency or if the vendor cannot supply the concrete, the City reserves the right to purchase concrete from another vendor. The bid is to be good for 12 months. Award will be based upon price of concrete on a per line item basis.
