
PUBLIC HEARINGS

1. A PUBLIC HEARING TO OBTAIN VIEWS ON THE HOUSING AND COMMUNITY DEVELOPMENT NEEDS OF THE CITY OF OPELOUSAS AND TO DISCUSS THE SUBMISSION OF AN APPLICATION FOR FUNDING UNDER THE STATE OF LOUISIANA FY 2021/2022 COMMUNITY DEVELOPMENT BLOCK GRANT (LCDBG) PROGRAM.
 - A. The amount of funds available for proposed community development and housing activities.
 - B. The range of activities available that may be undertaken, including the estimated amount of funds proposed to be used for activities that will benefit persons of low and moderate income.
 - C. The plans of the City for minimizing displaced persons as a result of activities assisted with such funds and the benefits to be provided by the City to persons actually displaced as a result of such activities.
 - D. The City's past performance on LCDBG projects funded by the State of Louisiana.
