With Mayor Julius Alsandor presiding, the meeting was called to order.

ANNOUNCEMENTS

- Announcement by Ms. Patrice Melnick regarding grants received for the Opelousas Museum & Interpretive Center. Ms. Melnick informed everyone that the Museum has been awarded two grants—one from the Atchafalaya National Heritage Area and one from the Louisiana Endowment for the Humanities Rebirth grant. These two grants will help to pay for a new exhibit that will be available in February at the Museum called "Free People of Color in St. Landry Parish from the 1700s to 1865". The exhibit will include a map of the Free People of Color communities as well as profiles and other related information. This will be a permanent exhibit. For more information about events at the Museum, sign up for the Email Newsletter she sends out or check out the Community Chronicles newsletter which has a monthly column about the museum. Alderman Ford thanked Ms. Melnick for all of her hard work in keeping the history of Opelousas moving forward.
- Following Ms. Melnick's announcements, Mayor Alsandor decided to handle Alderwoman Robert's item at this time. Presentation/Discussion by Alderwoman Sherell Roberts and Mr. George Davy regarding loose/dangerous dogs. Alderwoman Roberts began by saying that she wanted to bring up a discussion about dogs running loose in Opelousas and that she has been getting numerous calls in her district about dogs running free. She was interested in finding out if there is an intergovernmental agreement to get these dogs housed. She also wanted to know what the policy on these dogs biting people is. Mr. Davy, who resides in the 500 Block of S. Court Street in the Historic District, stated that on 04/12/2022 he was coming home from the park on Court Street when a pit bull came over a fence and mauled him. Mr. Davy provided a slide show of his injuries following the attack. He stated that the dog attacked his legs and when he bent down to push the dog away, it grabbed his chin and pulled him down. He stated that he was able to get his hands around the dog's neck and strangled it until the dog started squealing and let it go and ran back into its house. He said that the police, the ambulance, and the dog catcher came but he pointed out that the dog was only quarantined to its residence for 10 days. He pointed out that this same dog had also attacked another very prominent person in this town who beat it off with a stick. He stated that everyone would agree that this is a dangerous dog and according to Opelousas Code of Ordinances, the enclosure that holds the dog should be at least 8 feet high. This dog was enclosed in a 4 foot high chain link fence. There should have also been signs saying the dog is dangerous but there were none. The owner of the dog was renting but the ordinance also stated that owners of these types of dogs should have at least \$100,000 liability policy on these dogs. Mr. Davy stated that he doesn't sleep anymore because he is having nightmares about this dog and that that the owner of the dog was kicked out by the owner of the property following this incident but he does not know where the person went. Alderwoman Davis spoke emotionally at this time and stated that she knows how Mr. Davy feels because she was attacked earlier this year by a dog while she was pregnant and now she is afraid of dogs and she is sorry that this happened to him. He also pointed out that on the police report in the place to report injuries, it was checked off none. Mr. Davy is asking for closure on this issue and hoping that the City can help him. Mr. Davy stated that the owner of the dog was only issued a citation for a leash law. Alderman Richard stated that the owner of the dog should be held accountable for this because that could have been Mr. Davy's life. Alderwoman

Roberts stated that they are going to see what they can do about this and that the attorney has something about what the law has to say about it but they will definitely look into this. Attorney Broussard stated that he has been the city attorney for six years and he has had occasion to deal with the question related to dangerous dogs and also currently in his private law practice. This situation is easily addressed by State law, particularly under Title 14 (Criminal Laws), addressed at Sections 102.12, 102.13, and 102.14 and 102.15 (A) which places a lot of authority and discretion within Parish Government, as follows: §102.12. Definitions

- (1) "Animal control agency" means the parish or local animal control agency. If the municipality or parish does not have an animal control agency, it means whatever entity performs animal control functions.
- (2) "Impounded" means taken into the custody of the animal control agency or provider of animal control services to the municipality or parish where the dangerous or vicious dog is found.
- (3) "Secure enclosure" means a fence or structure suitable to prevent the entry of young children, and which is suitable to confine a dangerous dog in conjunction with other measures which may be taken by the owner of the dog. The enclosure shall be designed in order to prevent the animal from escaping.

§102.13. Hearing to determine if dog is dangerous or vicious

- A. The district attorney, the sheriff, an animal control officer, or other designated representative, in the name of and on behalf of the parish and without the payment of any costs, shall be authorized to file a petition in the district court having jurisdiction requesting a hearing for the purpose of determining whether or not a dog should be declared dangerous as defined in R.S. 14:102.14(A) or vicious as defined in R.S. 14:102.15(A).
- B. Upon the filing of the petition, the district judge shall immediately issue a rule on the owner of the dog to show cause why the dog should not be declared a dangerous or vicious dog. This rule shall, at the time of its issuance, be fixed for hearing not later than five days, including Sundays, halfholidays and holidays, from the date of its issuance, and shall be heard by preference over all other matters and cases fixed for the same day and shall
- be heard continuously day after day until submitted for adjudication.

 C. Upon the showing made by the parties on the trial of the rule to show cause, the court shall determine whether the dog is a dangerous dog or a vicious dog and may make other orders authorized by this Section.
- D. In every case where the dog is established to be a dangerous dog, the court shall enter an order declaring the dog to be a dangerous dog and shall direct the owner of the dog to comply with conditions established for the restraint and confinement of the dog as provided by law
- E. In every case where the dog is established to be a vicious dog, the court shall enter an order declaring the dog to be a vicious dog and shall direct that the vicious dog be humanely euthanized.
- F. Any person who fails to restrain and confine a dangerous dog as ordered by the court shall be guilty of contempt and shall be fined not less than
- one hundred dollars nor more than five hundred dollars.

 G. The pleading and practice in all cases under this Section shall be in accordance with the Code of Civil Procedure and the laws and rules of court governing practice before the district courts of this state.
- H. The owner of the dog may appeal to the court of competent jurisdiction an order of the district court determining the dog to be dangerous or vicious. Such appeal shall be perfected within five calendar days from the rendition of the order and shall be made returnable to the appropriate appellate court in not more than fifteen calendar days from the rendition of the order. The applicant for the determination may appeal to the court of competent jurisdiction for an order reversing the order of the district court. I. No dog shall be declared dangerous or vicious if at the hearing authorized by this Section evidence presented is sufficient to establish any of the following:
- (1) Any injury or damage is sustained by a person who, at the time the injury or damage was sustained, was committing a crime upon the property of the owner of the dog.
- (2) Any injury or damage is sustained by a person who, at the time the injury or damage was sustained, was teasing, tormenting, abusing, or assaulting the
- (3) Any injury or damage is sustained by a domestic animal which, at the time the injury or damage was sustained, was teasing, tormenting, abusing, or assaulting the dog.
- (4) If the dog was protecting or defending a person within the immediate vicinity of the dog from an unjustified attack or assault.
- (5) If the injury or damage to a domestic animal was sustained while the dog was working as a hunting dog, herding dog, or predator control dog on the
- property of, or under the control of, its owner, and the damage or injury was to a species or type of domestic animal appropriate to the work of the dog.

 J. The owner of a dog determined to be a vicious dog may be prohibited by the court from owning, possessing, controlling, or having custody of any dog for a period of up to three years, when it is found, after proceedings conducted pursuant to this Section, that ownership or possession of a dog by that person would create a significant threat to the health, safety, or welfare of the public.

§102.14. Unlawful ownership of dangerous dog

- A. For the purposes of this Section "dangerous dog" means:
- (1) Any dog which when unprovoked, on two separate occasions within the prior thirty-six-month period, engages in any behavior that requires a defensive action by any person to prevent bodily injury when the person and the dog are off the property of the owner of the dog; or
- (2) Any dog which, when unprovoked, bites a person causing an injury; or
 (3) Any dog which, when unprovoked, on two separate occasions within the prior thirty-six-month period, has killed, seriously bitten, inflicted injury, or otherwise caused injury to a domestic animal off the property of the owner of the dog.
- B. It is unlawful for any person to own a dangerous dog without properly restraining or confining the dog.
- C. A dangerous dog, while on the owner's property, shall, at all times, be kept indoors, or in a secure enclosure. A dangerous dog may be off the owner's property only if it is restrained by a leash which prevents its escape or access to other persons.
 D. The owner of a dog determined by the court to be dangerous shall post signs around the secure enclosure no more than thirty feet apart and at each normal
- point of ingress and egress. The signs shall bear the words "Beware of Dog", or "Dangerous Dog" in letters at least three and one-half inches high and shall be so placed as to be readily visible to any person approaching the secure enclosure.

 E. If the dog in question dies, or is sold, transferred, or permanently removed from the municipality or parish where the owner resides, the owner of a dangerous
- dog shall notify the animal control agency of the changed condition and new location of the dog in writing within two days.
- Whoever violates the provisions of this Section shall be fined not more than three hundred dollars.
- G. The provisions of this Section shall not apply to:
- (1) Any dog which is owned, or the service of which is employed, by any state or local law enforcement agency for the principal purpose of aiding in the detection of criminal activity, enforcement of laws, or apprehension of offenders.
- (2) Any dog trained in accordance with the standards of a national or regional search and rescue association to respond to instructions from its handler in the search and rescue of lost or missing individuals and which dog, together with its handler, is prepared to render search and rescue services at the request of law enforcement.
- §102.15. Unlawful ownership of a vicious dog

 A. For the purposes of this Section "vicious dog" means any dog which, when unprovoked, in an aggressive manner, inflicts serious bodily injury on or kills a human being and was previously determined to be a dangerous dog.
 - B. It is unlawful for any person to own a vicious dog.
 - C. Whoever violates the provisions of this Section shall be fined not more than five hundred dollars or imprisoned for not more than six months, or both.
 - D. The provisions of this Section shall not apply to:
 - (1) Any dog which is owned, or the service of which is employed, by any state or local law enforcement agency for the principal purpose of aiding in the detection of criminal activity, enforcement of laws, or apprehension of offenders.

 (2) Any dog trained in accordance with the standards of a national or regional search and rescue association to respond to instructions from its handler in the
 - search and rescue of lost or missing individuals and which dog, together with its handler, is prepared to render search and rescue services at the request of law enforcement.

Alderman Cummings asked Mr. Davy if he knew why the police report showed no injuries. Mr. Davy stated that he had no idea. He feels that the police report needs to be amended. Alderman Batiste stated that they need to talk to the Chief about updating that report. Mayor Alsandor stated that because of incidents of this type and the abundance of dogs that are running through the City, it is something that we have discussed internally here but also reached out to others in our surrounding area. Just yesterday, he and Mr. Purvis had a meeting with the Parish President of possible avenues or solutions. Mr. Wayne Ardoin, parish councilmember, was in attendance and has let them know that the Parish is overloaded as well. Years ago, we used to have a system to dispose of dogs that were within our possession for too long and he believes that it still exists. Mayor Alsandor pointed out that we are focusing on pit bulls but it applies to any dog that may be deemed dangerous. He doesn't want anyone to leave out with the misconception that all pit bulls are dangerous. The shelter and pound were not going to take the dangerous dog. The only other place to house the dog as it has bit someone is in the home it came from—and the dog was quarantined for 10 days. Mayor Alsandor assured Mr. Davy that the City is going to look into getting funding to house a small number of dogs.

A RESOLUTION AUTHORIZING A COOPERATIVE ENDEAVOR AGREEMENT WITH OPELOUSAS DOWNTOWN DEVELOPMENT DISTRICT FOR WATER AND WASTEWATER IMPROVEMENTS – WALLIOR STREET

WHEREAS, the Opelousas Downtown Development District ("ODDD") proposes to enter a cooperative endeavor agreement with the City of Opelousas ("CITY") for Water and Wastewater Improvements – Wallior Street and a copy of the cooperative endeavor agreement is attached to this Resolution;

WHEREAS, the CITY has determined that citizens and businesses will benefit from upgrades to the water lines and wastewater lines located under, along and to the East of Wallior Street, which improvements include new lines, pumps, manholes, and such other improvements as are necessary to serve the area, which area includes part of the Opelousas Downtown Development District;

WHEREAS, the Board of Commissioners of the ODDD agrees to partner with the CITY and to contribute all or a part of the cost of such upgrades;

THEREFORE, the ODDD does hereby agree that it will pay for the cost of the structural upgrades, up to the sum of \$250,000.00.

SECTION 1: CANCELLATION

This commitment will expire on December 31, 2023, unless extended or terminated by the ODDD Board of Commissioners prior to that time.

SECTION 2: EFFECTIVE DATE
This Agreement shall be effective August 1, 2022.

SECTION 3: PURPOSE

The purpose of this Agreement is to further economic development opportunities within the ODDD and within the City of Opelousas, and the Agreement shall be liberally construed to further that purpose. To that end, the Board of Commissioners of the ODDD and the Mayor and Board of Aldermen of the CITY shall work together to promote the well-being of the citizens of Opelousas by the improvement to the water and wastewater service.

SECTION 4: PAYMENT

Payments to the CITY shall be made by the ODDD within 30 days of receipt of invoices from the CITY.

WHEREAS, in a lawful public meeting convened by the Opelousas City Council on the 9th day of August, 2022, on motion of councilmember Marvin Richard and seconded by councilmember Floyd Ford, this Resolution was offered for adoption, and the following vote was recorded:
